LM 001/2024 Chairman's request

LM 002/2024 Apologies for absence and declarations of interest

Apologies were received from Cllr Kneen and Cllr Phillips

LM 003/2024 Election of the Land Management Chairman for the forthcoming year

Cllr Elvin asked for nominations for Chairman. Cllr Walters proposed Cllr Graham as Chairman, there were no further nominations. Cllr Graham agreed to be nominated, the nomination was seconded by Cllr Elvin Vote All
